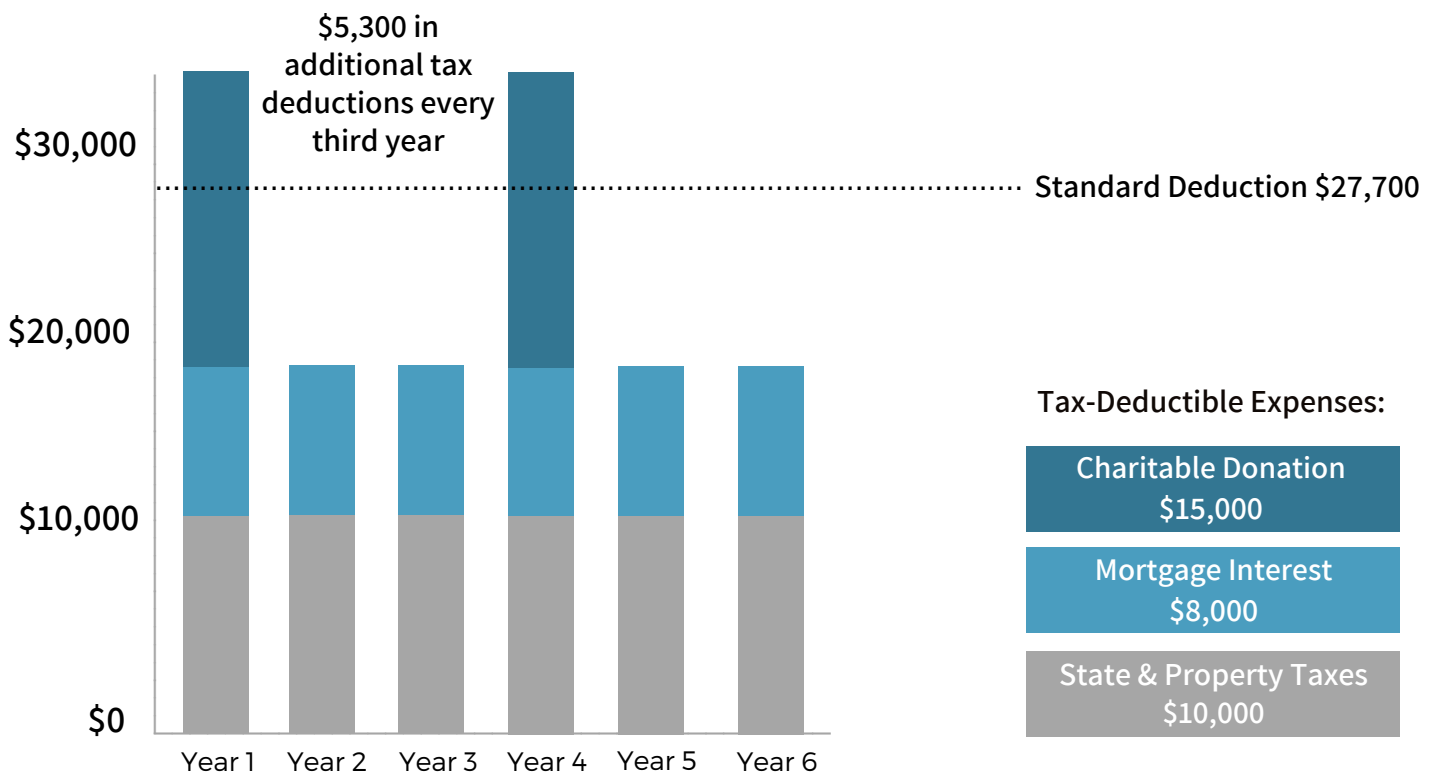


BUNCH YOUR DONATIONS USING A CFA DONOR ADVISED FUND

"Bunching" charitable gifts into a donor-advised fund allows maximum tax benefits under the new tax laws. This strategy allows individuals to exceed the new, higher standard deduction in the year a gift is made into a donor-advised fund as every gift to a donor-advised fund is tax deductible the moment it is made. The fund can then be used to make charitable gifts for the next few years.

In the included example, a married couple filing jointly, who typically make \$5,000 a year in charitable gifts, benefit from bunching a \$15,000 donation into a donor-advised fund every three years. This means the couple itemize in years one and four and take the standard deduction in the years between while still meeting their charitable goals.
