BE IT ORDAINED, by the Mayor and Council of the Town of Madisonville that Chapter 7 of the "Code of Ordinances" of the Town of Madisonville be amended by amending Section 7.4 and adding 7.4A and 7.4B to read as follows:

Section 7.4. It shall be unlawful for any person to post any signs, posters, bills of advertisement of any description on private property in the Town of Madisonville without first securing a special permit from the owner or custodian of said property on which said signs, posts, bills of advertisement are to be posted.

Section 7.4A. It shall be unlawful for any person to post or cause to remain any signs, posters, banners, bills of advertisement of any description on public property within the jurisdiction of the Town of Madisonville, unless erected by governmental authorities, without first securing a special permit from the Town Council.

Section 7.4B. Any such signs may be summarily removed in addition to penalties provided in the Code for the violation of Ordinances.

BE IT ORDAINED BY THE Mayor and the Council of the Town of Madisonville that the "Code of Ordinances" of the Town of Madisonville be amended as follows:

## CHAPTER 7, STREETS, SIDEWALKS, WHARVES AND PUBLIC WAYS

- Section 7.6:

  Commencing April 1, 1988 an annual permit sticker for each boat trailer shall be required for all persons using the Madisonville boat launch facility.
- Section 7.6(a):

  The permit sticker annual fee shall be \$12.00 per permit sticker which must be secured to the trailer on a easily observable location.
- Section 7.6(b):

  Persons 65 years of age or older are exempt from paying the annual fee but must secure an exempt sticker which must be attached to the boat trailer.
- Section 7.6(c):

  Any person violating the provisions of these boat trailer permit provisions shall be punished by a fine of not less than twenty-five dollars (\$25.00).
- Section 7.6(d):

  In lieu of paying this fine, such person may purchase or secure the proper permit sticker or exempt permit sticker within ten (10) days of the date the citation was issued.

## CHAPTER 7

Streets, Sidewalks, Wharves and Public Ways

- Section 7.1 All streets, roads, sidewalks, avenues, alleys, park and lanes which are used by the public are and are hereby declared to be public property and no one shall fence in streets, sidewalks, avenues, roads, alleys and lanes or to close and obstruct same in any manner.
- Section 7.2 The banks of the Tchefuncta River between Water Street and said river, within the corporate limits of the Town of Madisonville, La., and between St. Mary Street and St. Louis Street in said Town of Madisonville, La., be, and they are hereby declared to be public property and it's use is subject to regulations by the Town.
- Section 7.3 Vessels shall not tie up for over 24 hours at municipally owned whaves without special permit from the Town Council and shall pay wharfage fee which may be set by the Town Council.
- Section 7.4 It shall be unlawful for any person to post any signs, posters, bills of advertisement of any description in the Town of Madisonville on any of the streets, or property abutting on said streets without first securing a special permit from the owner or custodian of said property on which said signs, posts, bills of advertisement are to be posted and a permit from the Mayour.
- Section 7.5 It shall be unlawful for any person or persons, to use bicycles for the purpose of riding, or transportation upon the side walks of any streets and alleys within the Town of Madisonville, La. or to ride a bicycle after dark without a light.
